A Glimpse of The Sunken Lighthouse!

We watched with subdued excitement as our depth recorder printed the silhouette of a large pyramid-shaped object rising from a depth of twenty feet to within a few feet of the surface. Being a half mile from Cape San Blas, I found it hard to believe that just over a hundred years ago a proud lighthouse stood here surrounded by pine forests and a family or two of lightkeepers. Without a doubt, this cape has suffered from more erosion than any other shore in America.

We had been here several times before, but each trip was doomed because the chocolate-colored Gulf had prevented us from diving. Today, with tides and currents in our favor, the water was an eerie translucent green; clean enough to dive but not enough to make it enjoyable. We gazed apprehensively over the side at the large dark shadow just below the surface.

The steel skeleton tower that warns mariners today of the treacherous shoals is the fourth tower to be erected on the Cape. It was preceded by three impressive brick towers that now lie far offshore. The first lighthouse was built in 1847 and stood four years. A new light was begun and was completed in 1856; just in time for the "Great Storm of '56" to topple it.

award that is not presented every year and is given to someone who has earned special recognition. The award was accepted by Tom's sister, Ms. Kay Taylor. This award reads "The Florida Lighthouse Association presents the 2004 Presidents Award to Thomas W. Taylor for outstanding service on behalf of Lighthouse Preservation".

Gene further announced that the Board of Commissioners, in the business meeting conducted earlier, voted unanimously to change the name of the President's Award to the Tom Taylor Award. From this day forward, it shall be known as such.

There being no old or new business to discuss, and with the Reports having been given, the group proceeded to raffle and auction. The proceeds were given to Charlie Knox to be submitted to George Diller, Treasurer.

The meeting was adjourned at 4:15pm.

LITTLE LIGHT TRYING TO MAKE A BIG LIGHT

We in the Tampa Bay Harbour Lights Collectors Club are just a little group - a little light as you might call it - trying to make a big difference. We are small but we are PASSIONATE about what we do and our love for lighthouses. We raise money and we make small differences but we also make big differences. One of our prouder moments happened two years ago when 50 of us took a two week lighthouseseeking venture to the West Coast. One of our stops was the Point Sur lighthouse in California. They were in the process of a massive restoration / preservation effort and we were IMPRESSED - they really had a direction and were making tremendous strides in achieving their goals. The work they were doing really showed. One of their fundraising efforts involved selling prisms for the lantern room floor to replace those stolen and vandalized over the years. The prisms cost \$1,000. - We were IMPRESSED !! What a great way to make money and allow someone to become a part of the history of your lighthouse forever. During the last leg of our trip, we voted to donate a portion of our profits from the trip and buy one of those prisms – and that's exactly what we did. Our small group now has a place in the history of the Point Sur lighthouse. That donation has since been matched by other groups. Now we're looking to make a place in the history of something even closer to our hearts - Florida's **lighthouses**. During the last meeting of the *Florida* Lighthouse Association (FLA) at Anclote Key in April, our president, Wayne Hawes, issued a challenge to every person, every group, and every organization by donating \$1,000. from our limited treasury monies to the FLA for the Florida License Plate Project. St. Marks Lighthouse - July 16, 2005

CLIMB THE WOODEN STEPS

Many of us have visited St. Marks Lighthouse in the past and admired the stately lighthouse as we roamed and explored its tranguil location. It is rarely open for climbing, so most of us have never had that privilege. TIMES HAVE CHANGED! Thanks to the Coast Guard, St. Marks Lighthouse will be open for us during our next meeting on July 16. This is a unique opportunity in that St. Marks is the only lighthouse in Florida with wooden stairs. The stairs are connected to a large wooden pole that stands in the center of the tower and close examination shows that the stairs are attached by nails. The current tower is the third St. Marks Lighthouse, being rebuilt following the Civil War. The tower was then heightened to its present focal plane of 82 feet and received a new fifth-order Fresnel lens. The tower was automated in 1960. In 2000, the Coast Guard spent \$150,000 to repair and stabilize the lighthouse. The fifth-order lens is still in place but the 2,000 candlepower flashing light is now produced by a modern solar-powered 250mm optic attached to the gallery railing.

Due to its remote location far removed from modern amenities, our lodging and meeting / luncheon will be hosted by the Radisson Hotel Tallahassee. Our meeting will begin with registration at 8:30am immediately followed by the third quarter meeting of the FLA starting promptly at 9am. Seating space is limited so register early. Our guest speakers will be Mr. Ken Smith and Mr. Fred Gaske. Mr. Smith is a Jacksonville architect who has managed extensive restoration work on lighthouses and historic buildings. His company has designed restorations for St. Augustine, Ponce Inlet, Fowey Rock, Anclote Key, Amelia Island, Sapelo Island, and Tybee Island His company, in conjunction with Liahthouses. Bender and Assoc. Architects, performed the survey of all Florida's lighthouses including St. Marks for the Department of Historic Resources in 2000. Mr. Fred Gaske is the Director of the Florida Division of Historical Resources and serves as the State Historical Preservation Officer. This office provides many thousands of dollars in the form of grants to restoration projects. He will discuss how the Division of Historical Resources has assisted (and can continue to assist) in the preservation of Florida's historic lighthouses.

The luncheon will be held after the meeting followed by the drive out to St. Marks National Wildlife Refuge. You will need to purchase a daily pass for \$4./per vehicle. Upon entering the National Refuge, the park system has a unique shop / learning facility well worth the time to visit. Our group will be met at the lighthouse at approximately 3pm by the Coast Guard and staff of the St. Marks National Wildlife Refuge - Refuge Manager James Burnett, Ranger David Moody and Ranger Andrew Edel. Due to the time of year and driving distance, light refreshments will be served in the keeper's dwelling. The Coast Guard will open the tower and we will have the privilege of going back into the past and climbing the wooden stairs to the top. The only limitation in this climb will be the outside of the lantern room. The hand rails and life lines are worn, thereby posing a safety hazard to all. We will be able to see the Fresnel lens and view the current lighting system from inside. Ranger Edel is currently working on several presentations including a living history with the "troops" that were stationed at Ft. Williams, next to the Refuge, during the Civil War. Hopefully this presentation as well as a Power Point presentation will be completed in time for our meeting.

The cost for this meeting including luncheon, facility rental, light refreshments, and a donation to the lighthouse will be \$25. per person.

- D. Ponce Inlet. A new exhibit at the Ponce de Leon Inlet Light Station, traces the history of lighthouse illumination from primitive bonfire signals to the modern marine beacons, used by the U.S. Coast Guard today. The exhibit also features numerous lighthouse illumination artifacts, as well as reproduction 4th and 6th Order Fresnel Lenses. But, the highlights of the exhibit are two original, 1st Order Fresnel Lenses. One was in the Cape Canaveral Lighthouse from 1876 until 1993, and the other was in the Ponce Inlet tower from 1887 until it was replaced by a 3rd Order Fresnel Lens in 1933.

This 1933 lens was recently restored, and was reinstalled in the tower last year. In celebration of this event, a special program called, "Climb With the Keepers" has been started. Visitors can climb with the "1930s keepers" and go inside the Lantern Room, of the 2nd tallest lighthouse in the U.S.. The next program is on September 7, 2005. - Q. St. Marks. Bill H. R. 372 for the transfer of the lighthouse to the National Wildlife Refuge at St. Marks has finally passed in the Congressional Committees of the 109th Congress. The bill must now be placed on the agenda of the House of Representatives. Hopefully it can be addressed and voted on before Congress's summer recess in August.
- R. Crooked River. (from Barbara Revell) - Carrabelle Lighthouse Association (CLA) Inc. elected new officers in March. The new President is Mary Katzer, who comes with great enthusiasm and energy! She has been interested in lighthouses since she was a child growing up near Lake Michigan in Milwaukee, WI. She lived a number of years in Ft. Lauderdale and was a cofounder of the still operating Ocean Watch. Last year Mary moved to Carrabelle and has been active in CLA since. On Saturday, April 2, 2005 there was a dedication ceremony of a wonderful replica of Crooked River Lighthouse which has been installed in the Welcome Park (just east of Carrabelle). This was a joint effort between CLA and the Sea Oats Garden Club. Also

participating in the event was the Chamber of Commerce. The replica was built by former CLA President, Ron Treutel. This replica was entered in the Carrabelle's Parade of Lights in December and won first place. The replica is now permanently installed in the park and a wonderful addition to the City of Carrabelle. Now there are two Crooked River Lighthouses in Carrabelle...one at each end of the City! CLA will be participating in Carrabelle's annual Riverfront Festival on April 23 and 24th. (from Dianne Levi) - Barbara was too modest to mention the road from Rt. 98 to the Crooked River Lighthouse has been named Barbara Revell Lane and a street sign installed at the corner of the lighthouse road and Rt. 98. The lighthouse site has been cleaned up and trees taken down to make the lighthouse much more visible from Rt. 98.

- U. Saint Joseph's Point.



Whereas it is the goal of our member, the Hillsboro Lighthouse Preservation Society, Inc., to preserve and restore one of the original 1-1/2 story Keeper's Quarters that was built at the Hillsboro Inlet Light Station in 1906; and

Whereas it is the stated intention of the Hillsboro Club to replace this historic Keeper's cottage, which had been moved to the Hillsboro Club in the 1930s, with a modern two-story structure in the same foot print for use by club members; and

Whereas the Hillsboro Club has offered to transfer ownership of the cottage to the Hillsboro Lighthouse Preservation Society; and

Whereas this cottage is one of the 12 oldest buildings in Broward County and one of the oldest in the Town of Hillsboro Beach; and

Whereas there are several advantages to saving the cottage;

- This historic structure can become a maritime museum and an education classroom with scheduled access by school children, local residents, and visitors.
 - It can be a neighborhood and community meeting place for small groups.
 - The 1906 cottage can be independently certified as a Historic Building.

Therefore, the Florida Lighthouse Association does covenant with the Hillsboro Lighthouse Preservation Society, Inc. to show support of their intent to accept the deed of the historic 3rd Keeper's Quarters and to show support of their intent to preserve and restore same with the aid and assistance of a community partnership.

Adopted by unanimous vote of the Board of Commissioners of The Florida Lighthouse Association, Inc. in business meeting assembled on the 15th day of April 2005.

Link to Sanibel Lighthouse Lost



Keeping the Lights for Kids

Many of us grew to love lighthouses as children, cherishing a favorite shore side vacation spot and its tall lighthouse, or touched by a special storybook tale of a lighthouse. Hildegard Hoyt Swift's *The Little Red Lighthouse and the Great Gray Bridge* was one

of my childhood books. So was Julia Sauer's *The Light at Tern Rock*. Though lighthouses were far from my home on a farm in western Maryland, those stories took me to the water and the world of ships and bridges.

In October 2004, I spent two weeks visiting schools in Florida, sharing my love for lighthouses with students and letting them join me in celebrating the debut of my new book, *Florida Lighthouses for Kids*. It's a tidy little tome that provides just enough facts and fun to encourage more learning, perhaps even a lifelong interest. Pineapple Press of Sarasota published the book and scheduled me for a book tour two weeks after its expected arrival from the printer in Singapore.

A lot of my own inner child went into *Florida Lighthouses for Kids*. I hope it is the first of many state lighthouse books I'll write for youngsters. This article is also a plea for FLA to expand and beef up its youth education mission. We're off to a good start, but we can do much more. Teachers, in particular, are asking for our help. Nothing we do with kids is wasted time. They are our future members and future preservationists. If we teach them <u>now</u> how to cherish and care for lighthouses, they'll accept the task willingly and lovingly in years to come.

I can attest to their enthusiasm and readiness. My two week school tour put me in contact with more than 2,000 kids. They drew pictures for me and made thank-you notes with beaming lighthouses on their covers. They listened to my stories and then wrote their own, plus poems and cartoons and jokes. They made lighthouses out of boxes, paper cups, Kool-Aid cans, paper towel tubes, and flowerpots. One child made me a lighthouse pin. These are gifts I cherish, because they say, "You taught me to be passionate about something and to share it with others."

There were funny moments too, and tender ones. Kids can be brutally honest but also amazingly sincere. They laughed when I tripped over the projector cord at one elementary school, then rushed from their seats to pick me up off the floor. "Are you okay, lighthouse lady? Should we get the school nurse...call an ambulance" I laughed at myself and told them I hoped the same thing didn't happen to Cape St. George Lighthouse. At another elementary school, a class sang me a song they had

made up about lighthouses. "May you stand forever tall, may your bright light guide us all," they crooned in lilting child voices. Good thing I brought tissues.

As I write this today (May 13, 2005), I am engrossed in a new project. A few months ago, I founded the WLA (Washington Lightkeepers Association) and became its charter president. It will serve as a unifying entity in my state, bringing together lighthouse groups, museums, businesses, families, individuals, and government agencies to care for our lighthouses and perpetuate their history and lore. And, of course, it will have a grand youth initiative called Keeper Kids. It's been a busy few months since the group's inception, but I am happiest when doing lighthouse work, especially with kids. Not surprisingly, it was a student who coined my well-known handle, "Lighthouse Queen."

FLA has inspired me and served as a model for my new group. My conversations with FLA members and officers and their generous help in all areas of nonprofit work has reached across the nation to the Evergreen State. There are many platitudes I could offer here, but I must thank a few people for their help—Kathy Fleming, Gene Oakes, Hib Casselberry, Paul Bradley, Wayne Hawes, and all those wonderful TBHLCC people who take me out on the town whenever I come to Tampa. Thank-you also to the many FLA members who have become members of WLA. Reciprocity is a valuable and noble thing. I hope you'll come west and join some of our activities over the coming years. We'll do likewise and visit you.

I would be remiss if I didn't thank the late Tom Taylor. He gave so much to lighthouse education and worked with me on many projects involving students. There are many honorary angels in our respective groups. Tom is a very special one.
